


**PHYSICAL EFFICIENCY TEST AND PHYSICAL STANDARD TEST**

You are informed to report to the **Principal, Police Training Centre (PTC), Banderdewa at 6:30 AM, Gate No:01** on the above-mentioned date positively with proper sports dress, water and light eatable item for PET & PST for selection to the post of Dy. Supdt. (APPS-EG) as per your preference exercised already.

**MEDICAL TEST**

You are also required to report to the **Chief Medical Superintendent, TRIHMS, Naharlagun** for Medical Test from 21.07.2025 onwards, if you qualify in the PET & PST conducted at PTC Banderdewa. The expenditure (if any) on Medical Test is to be borne by the candidates themselves.

**Important Instructions: -**

1. Check the Admit Card carefully and bring discrepancies, if any, to the notice of the APPSC immediately.
2. Admit Card must be preserved till the declaration of the final results of examination.
3. Entry for candidates into the Police Training Centre (PTC), Banderdewa will be open from 06:30 AM and will close at 08:30 AM. No entry will be allowed once the gates have been closed.
4. **The candidates are advised to reach the Venue well in advance considering the time for Biometric Authentication and Id verification.**
5. **Mobile phone, personal belongings and other objectionable articles will not be allowed inside the premises of the PTC, Banderdewa.** The commission and PTC will not be responsible for any loss in this regard.
6. Resorting to any type of unfair means/impersonation etc. may result in cancellation of candidature and necessary action will be taken by the Commission as per the rules.
7. No person, other than the candidates with valid Admit Card shall be allowed inside the premises of the PTC, Banderdewa till the completion of the PST and PET process. Parents/guardians accompanying the candidates shall have to wait outside the main gates of the PTC.
8. Candidates will have to submit an undertaking (format will be provided at the venue) before taking the Physical Efficiency Test that they are appearing the physical test at their own risk.
9. The Commission reserves the right to amend, revise, and reissue these instructions at any time during the examination process.
